Last day to object or withdraw nomination papers - Wednesday, March 9, 2022 by 5:00 p.m.

Last day to register voters for the Annual Town Election - Tuesday, March 22, 2022 by 8:00 p.m.

Richardson Building - 307 Main St. Gilbertville on Tuesday, March 22, 2022 from 9:00 a.m. to 8:00 p.m. This is the last day and hour to register voters who wish to vote at the Annual Town Election. 
Financial Statements
