Start times/sessions may be changed once all entries have been received, depending on entry numbers, and at the discretion of the Meet Director and Meet Referee. Teams will be notified of exact times by e-mail Wednesday, July 13, 2022.

ASSUMPTION OF RISK: We, Greenwood Swimming, have taken enhanced health and safety measures – for athletes, coaches, officials, volunteers, and meet management. You must follow all instructions while participating in/spectating at Greenwood Outdoor Specialty Meet or on site at Gardner Outdoor Pool. An inherent risk of exposure to COVID-19 exists in any public place where people are present. COVID-19 is an extremely contagious disease that can lead to severe illness and death. According to the Centers for Disease Control and Prevention, senior citizens and guests with underlying medical conditions are especially vulnerable. By participating in/spectating at Greenwood Outdoor Specialty Meet and being on site at Gardner outdoor pool, you voluntarily assume all risks related to exposure to COVID-19.

RELEASE: *An inherent risk of exposure to COVID-19 exists in any public place where people are present COVID-19 is an extremely contagious disease that can lead to severe illness and death. According to the Centers for Disease Control and Prevention, senior citizens and individuals with underlying medical conditions are especially vulnerable. USA Swimming, Inc., cannot prevent you (or your child(ren)) from becoming exposed to, contracting, or spreading COVID-19 while participating in USA Swimming sanctioned events. It is not possible to prevent against the presence of the disease, therefore, if you choose to participate in a USA Swimming sanctioned event, you may be exposing yourself to and/or increasing your risk of contracting or spreading COVID-19.*

By attending or participating in this competition you voluntarily assume all risks associated with exposure to Covid-19 and forever release and hold harmless USA Swimming and New England Swimming and each of their Officers, Directors, Agents, employees or other representatives from any liability or claims including for personal injuries, death, disease or property losses, or any other loss, including but not limited to claims of negligence and give up any claims you may have to seek damages, whether known or unknown, foreseen or unforeseen, in connection with exposure, infection and/or spread of Covid-19 related to participation in this competition.

SAFETY PROTOCOLS DUE to COVID RESTRICTIONS (subject to change based on CDC or Facility guidelines):

SAFETY PRECAUTIONS: (Pool is outdoors)

- There are no restrictions to the number of people permitted in the pool at one time.
- There are no restrictions to the number permitted on the pool deck.
- There are no spectators allowed on the pool deck at any time during the meet. Spectators will be allowed only in Designated area. Only coaches, officials, meet staff, timers and swimmers are allowed on deck.
- Teams/families are responsible for making sure their athletes/staff do not have a temperature or any COVID symptoms.
- There is no need to wear a face mask covering or social distancing outdoors, but everyone should be respectful of others.
- Any parent or legal guardian requesting access to their child will be allowed following all safety guidelines, by contacting Dan Warner at 978-852-3985.

MEET FORMAT: The meet will be swum as timed finals. Each session will be seeded by computer based on scratches received by the scratch deadlines. All events will be seeded slowest to fastest. No deck entries will be accepted. At the decision of the Meet Director and Meet Referee, events may be seeded on-deck using a positive check-in process.

DISTANCE EVENTS: The 500 Freestyle will be seeded slowest to fastest.

SCRATCH DEADLINES: Scratches for Saturday events by 5:00 PM Friday via email to nssc1@aol.com
Scratches for Sunday Events are due by 5:00 PM Saturday to Admin Official (Dan Warner) at the meet, or via email to nssc1@aol.com Although there is no penalty for failure to compete, please properly scratch by the deadline so as to ensure full heats and ensure the best possible competitive experience for all.

SITE: The Gardner Competition Pool is an 8 lane, 25-yard pool with 7 foot-wide lanes and non-turbulent lane lines. The timing system includes a fully automatic Colorado Time Systems electronic timing system with touchpads at the finish end of the pool. There will be backup buttons at the turn end of the pool to accommodate the 25 yard events. There are no touchpads at the turn end of the pool. Attached to the main pool is an area that is available for warm-up and warm-down. The start/finish and turn ends of the pool range from 13 feet deep to 4.5 feet deep. The pool is located at the Garner Outdoor Facility, 69 Park Street Gardner MA, 01440. Enter through the main entrance on Park Street. Directions may be found later in this document. The competition course has not been certified in accordance with 104.2.2C(4).

COURSE: Short course yards (25 yards)

RESERVE THE RIGHT TO MAKE CHANGES: Once a meet is sanctioned, changes can be made to the meet invitation before the meet, only with the approval of the Technical Chair, [Patrick Johnstone](#). Any change to the meet format after the meet begins will be at the discretion of the Meet Referee and will be presented to the coaches at a coaches meeting.

MEET COMMITTEE/ JURY: The Meet Jury will be made up of one official, one coach, and one athlete to be selected by the Meet Referee who will present issues and moderate the Meet Jury but not vote. When possible, the three members shall be from separate teams. The Meet Jury will decide all issues of eligibility, and anything not addressed in the Meet Announcement. The Meet Referee shall have authority as described in the current USA Swimming Rulebook.

CUT PROTOCOL: If a session is over-subscribed, the Meet Director, in conjunction with the Meet Referee, reserves the right to implement the following changes to meet format, in any order deemed necessary:

- 1) Relays may be limited up to a maximum of 1 relay per team.
- 2) The daily maximum event limit may be lowered.
- 3) Events may be cut by time.

WEATHER PROTOCOL: If weather or facility conditions make it impossible to follow the original timeline of events, the Meet Director and Meet Referee have a right to make changes to the meet sessions. The Meet Director will notify the teams of the changes with as much notice as possible. Cancellation of the meet, or a session, is a decision of the Meet Director and the Meet Referee.

ELIGIBILITY: All swimmers must be currently registered as athlete members of United States Swimming. Age is determined by the age of the swimmer on the first day of the meet.

Any swimmer entered in the meet must be certified by a USA Swimming member-coach as being proficient in performing a racing start or must start each race from within the water without the use of the backstroke ledge. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.

DISABILITY SWIMMING: Any current athlete members of USA Swimming with a disability, as defined by USA Swimming Rules and Regulations, may enter this meet if they meet the [USA Swimming Para LSC Motivational Time Standards](#). If modifications to USA Swimming rules are necessary, then the coach or athlete must notify the Meet Referee and Meet Director of any disability prior to competition.

SWIMWEAR: Per USA Swimming rules (102.8.1.F), 12 & Under swimmers may not wear a Technical Suit at any Sanctioned, Approved, or Observed meet. The age of the swimmer is determined on the first day of the meet. Guidance on identifying compliant and non-compliant suits can be found on the USA Swimming website under [Tech Suit Restriction for 12-and-Under Swimmers](#).

REGISTRATIONS: All swimmers must be registered (including proof of age and payment) with USA Swimming before 5:00 pm on the Thursday before the first day of the start of the meet. New England teams are required to check their entries with the online registration check tool on the New England Swimming website to verify registration status. Coaches must be registered before the start of the meet.

FALSE REGISTRATIONS: If a swimmer who is not properly registered with USA Swimming competes in a sanctioned competition, will impose a fine of up to \$100.00 per event against the individual, member coach, or a member club submitting the entry. The meet host will also lose their meet deposit.

DECK REGISTRATIONS: Will not be accepted.

DECK ACCESS: Only current USA Swimming registered athletes, coaches, officials, and official meet staff are permitted on the pool deck. All non-athletes on the pool deck must produce proof of their valid USA Swimming registration when asked. Deck Pass is an acceptable proof of membership. Individuals without proof of a valid membership in USA Swimming will be removed from the pool deck and will be fined by New England Swimming of \$100 to the coach, and \$200 to the coach's club.

DISABILITY SWIMMERS: Any current athlete members of USA Swimming with a disability, as defined by USA Swimming Rules and Regulations, may enter this meet. If modifications to USA Swimming rules are necessary, then the coach or athlete must notify the Meet Referee and Meet Director of any disability prior to competition.

ENTRY INFORMATION:

Qualification period: January 1, 2020 through the entry deadline.

All entry times must be entered in the course achieved.

Payment due date for all entries: within 4 days of confirmed entry acceptance. Any team that fails to send payment, cover page and waiver form, by this due date can be scratched from the meet at the discretion of the Entry Chairperson.

Any team that has been entered into the meet but is prevented from attending due to a change in restrictions imposed by state or local health authorities or the facility shall not be responsible for any meet fees.

Entries will be acknowledged within 48 hours of the first date of entry if they are accepted into the meet. *Your entry is considered received only if you receive an acknowledgement. Once you send your entry you are obligated to attend and pay the required fees.*

All unattached swimmers must be declared as unattached, on the entry cover sheet, before the meet begins.

Any team who has not paid their meet fees by the start of the meet will be assessed a \$100 fine. If no payment is received after 30 days, the fine is doubled. This fine is payable to the Greenwood Swimming. Late payment of entry fees may result in future exclusion from meets hosted by our club.

Any swimmer who is entered with incorrect swimmer information, or an incorrect or no ID, or is unregistered, will be scratched from the meet until corrections are made per the New England policy.

ENTRY LIMITS: Athletes may enter as many events as they choose but may only compete in a maximum of 6 individual events per day and a total of 10 events per meet. Time trials count in the per day event count.

VERIFICATION – SWIMS DATABASE PROOF OF TIME: Times must meet the qualifying time standards and any entry times not in the SWIMS database will be rejected except for 8 & Under 25 yard events. (NT's NOT ACCEPTED) All entries will be verified before the meet.

ELECTRONIC ENTRIES: Electronic entries (such as from Hy-Tek Team Manager or other team management software) that are in CL2 or SD3/SDIF format should be emailed as an attachment to the entry chairperson at nssc1@aol.com. Please check that your team name, address, and contact information are listed correctly in this file. For email entries, payment and hardcopy of the entry (including signed entry cover page and waiver) must be received within 4 days after the entry is confirmed by e-mail.

LATE ENTRIES: Entries submitted after the entry deadline will be subject to a fine of \$100 per team. No swimmers or swims may be added after Monday, July 11 at 5:00 PM.

NEW QUALIFYING SWIMS: Swimmers qualifying for the meet for the first time after the entry deadline, as well as qualifying swims achieved after the entry deadline, for swimmers already entered in the meet, may be added to the meet until Monday, July 11 at 5:00 PM. These additions must be sent directly to nssc1@aol.com, including the swimmer's full name, registration information, and entry times. Do not send a new entry file.

ENTRY TIME UPDATES: Entry times may not be updated after the entry deadline.

ENTRY TIME VERIFICATION: All entry times must be provable via USA Swimming sanctioned, approved, or observed meets. New England Swimming will verify all times in SWIMS. Any times not provable are subject to a fine of \$100 per event.

RELAYS:

- Dual Human Confirmation of relay take off violations will be required at all New England Swimming meets.
- Use of Electronic Relay Judging Pads: If Electronic Relay Judging pads are to be used at a meet, they will serve in the following capacity. Once a Dual Confirmation of a relay take off has been confirmed (Dual Human Confirmation), the Meet Referee or his/her designee shall request the RJP data. This data can only be used to support the disqualification or overturn the disqualification. In the event the RJP data is either missing or deemed invalid, the disqualification will stand.
- No limit on the number of relays entered per team per event but only 2 relays per team can score.

- All relay swimmers must be officially entered into the meet.
- Unattached swimmers may not participate in any relays.

TIME TRIALS: Time trials will be offered at the discretion of the Meet Director and the Meet Referee if time allows. Time trials are \$10.00 for individual events, and \$25.00 for relays. If a swimmer is not entered in the meet, they will also owe the \$2.00 travel fee.

LEGAL SPLITS – Individual Events: Preferably, legal splits should be requested before the event, by a coach, using a legal split form (available from the Control Table) and the requesting party should supply an additional timer(s) on the lane for the split, if necessary, to ensure an accurate time. (1 timer with touchpad timing, 3 timers without touchpad timing). Timers must be positioned over the lane at the end of the racing course. Optionally, a legal split may be requested after the event using a legal split form when using a fully automatic timing system. The Admin Official has discretion to either grant or deny the request after reviewing the available evidence. Backstroke legal splits must be requested in advance to ensure a legal finish.

LEGAL SPLITS – Relays: All lead-off splits for relays are automatically loaded into SWIMS and do not require additional watches for validation unless there are no touchpads present, or the second swimmer starts in the water. If there are no touchpads, or the second swimmer starts in the water, a legal split form with three watches will be required for entry into SWIMS. Timers must be positioned over the lane at the end of the racing course. It is recommended that coaches report lead-off time discrepancies to the Administrative Referee or Administrative Official.

ADMISSION: No Charge

MEET MOBILE: will be functional for this meet, (dependent upon satisfactory internet access) All users should be aware that Meet Mobile publishes unverified raw data that may not always be accurate.

OFFICIALS: Officials that know they will be attending the meet are highly encouraged to email the Meet Referee and let him/her know your level of certification, team, and sessions you will be available. Walk-on officials may not be accepted to limit the number of people on the deck. [INTENT TO OFFICIATE](#)

WARM-UPS: The pool will open for warm-ups as designated on the event list. The pool will close five minutes before the beginning of each session. Teams will be assigned warm-up lanes after all entries are received. A designated area will be available during the meet for warm-up and warm-down.

SAFETY:

- Diving will be prohibited during warm-ups except in specifically announced one-way sprint lanes. There will be no diving in the warm-up and warm-down areas at any time
- No shaving is permitted at the competition site.
- No glass containers are permitted within the facility.
- Swimmers must be under the supervision of a coach. If a swimmer arrives at the meet without a coach, the swimmer should notify the referee before he/she warms up. The referee will assign the swimmer to a registered coach for warm-ups.
- Use of audio or visual recording devices, including a cell phone, is not permitted in changing areas, rest rooms, locker rooms, behind the blocks, or in any marked NO CAMERA ZONE.
- Deck changes are prohibited.

DRONES: Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas and open ceiling locker rooms) any time athletes, coaches, officials and/or spectators are present. Exceptions may be granted with prior written approval by the Vice President of Program Operations.

RULES: Current USA Swimming rules will govern all competition. Decisions by the Meet Referee will be final unless a written protest is lodged within 30 minutes of the heat swum. All swimmers, coaches and officials will follow the USA Swimming code of conduct under article 304 of the USA Swimming rules and regulations. Any violation of such policy will be reported to the Meet Referee and the New England Swimming office for further review and/or action.

SAFE SPORT: The conduct of all participants and spectators at a meet is governed by USA Swimming Rules 304/305. Any and all infractions must be reported to the Meet Referee or Meet Director.

All applicable adults participating in or associated with this meet acknowledge that they are subject to the provisions of the USA Swimming Minor Athlete Abuse Prevention Policy ("MAAPP 2.0"), and that they understand that compliance with the MAAPP 2.0 policy is a condition of participation in the conduct of this competition.

USA Swimming and NE Swimming encourage all to report any witnessed or suspected forms of abuse/safe sport violations to the NE Swimming Safe Sport Chair, Anne Kaufman: nesafesport@gmail.com (857-928-3638) or through the [USA-S online reportable form](#).

VIDEO STREAMING: All video streaming must be approved in advance by the Meet Director. Any such video stream must conform to all current Safe Sport policies defined by USA Swimming, New England Swimming, and the Meet Host. No video stream may originate from behind the starting blocks or from any other area marked as a NO CAMERA ZONE.

ON DECK PHOTOGRAPHY: As per New England Swimming policy, professional photographers contracted by Greenwood Swimming or the press photographers who have been approved in advance by the Meet Director, are allowed on deck. Use of audio or visual recording devices, including a cell phone, is not permitted behind the starting blocks, including in any spectator area behind the starting blocks, nor in any other marked NO CAMERA ZONE, including on deck. All NO CAMERA ZONES will be clearly designated. Email the Meet Director with questions and requests.

TIMING ASSIGNMENTS and "NO SHOW" WORKERS: All teams will be assigned to time based on the number of entries. A team will be fined \$100 per incident if it does not provide the timers it has been assigned, and will not be allowed to enter swimmers in another New England meet until the fine(s) is paid. This can be appealed to the Admin Review Board of New England Swimming and is enforced only if the meet management has properly assigned timers based on the number of swimmers a team has entered in the meet.

AWARDS:

- Medals will be awarded for places 1–8 in individual events. Ribbons will be awarded for places 9-16 in individual events.
- Medals will be awarded for places 1-3 in relay events. Ribbons will be awarded for places 4-8 in relay events.
- High-point awards for 10 & Under swimmers will be awarded to places 1-8. The 8 & Under 25 yard events are not considered for this award.

- Team awards will be presented to places 1-3. The 8 & Under 25 yard events are not considered for these awards.
- **Gong Heats:** Random Heats will be announced throughout sessions and that heat winner will receive a special prize.
- Swimmers and coaches are responsible for making sure they are present to receive their awards. All awards can be collected by teams at the control table on Sunday.
